Communications – Town Clerk stated that Legal Notice was placed in the Daily Gazette on March 17, 2018 advising the public of a temporary order limiting roads to 4 ton on Town of Galway Roads. The following correspondence was received and forwarded to Board Members: Building Department Report covering 3/13-4/10/18; NYSLRS Employer e-news for March; Resignation letter from Justice Justin Cappon effective March 31, 2018; Resignation letter from Teresa Brett from her position on the ZBA; Assessor Report for April; Pavilion Usage Request – Town Clerk waived \$50 fee for usage authorized thru Supervisor Lent for rest stop for the yearly Tour de Cure to be held on June 10th; Request for after prom support; Budget Amendments; Notification from Comptroller's office of Town Finance School to be held in May in Saratoga Springs & Ellicottville & the Highway Maintenance Report for March with schedule for April. Other Correspondence Received: Signed Nutrition agreement with Saratoga County Office for the Aging and Town & Grant application for the purpose of securing a \$100,000 grant from the NYS & Municipal Facilities Program-Town Clerk advised that a resolution by the Town Board is required for grant applications.

COMMITTEE/LIAISON/DEPARTMENT HEAD REPORTS: Youth Commission – Donna Sowle, Chair advised pee wee wrestling ended last Wednesday with over 40 children participating. Junior Rifle Team continues to do well, many youths have received college scholarships for their shooting ability. Councilman Smith stated that Logan Ogden went thru this program is in the Air Force now and is ranked highest for his shooting ability. He will be competing in South Korea for shooting. Recreation soccer will run May 12th thru June 16th, with Monday & Wednesday practice days. Councilman

Smith will have school get the port-a-potty from Charlton Septic and pay for it until our programs start. Family Fun Day will be held at Town Hall on June 16th from 1-4 p.m. Summer Recreation will be held at the Bus Garage this year due to school construction project. It will run for 4 weeks starting the 2nd week in July for children 4 years of age thru 6th grade. Highway- Dave Costanzo, Highway Superintendent stated for March the Highway Department plowed and sanded 8 days; mixed sand & salt; cut brush & overhead limbs on Big Murry Road, Cruthers Road & Spring Road; posted roads for 4ton weight limit & patched. The schedule for April is to sweep roads & intersections; cleaned up after wind storm; cut brush & overhead limbs; haul gravel; start construction on Dean Lung Road & spring equipment maintenance - remove plows. Board went into discussion regarding National Grid response time after recent storm, huge limb is still on road side of NYS Route 147. Fire Department was at this location for 16 hours before National Grid addressed issue on NYS highway. Resident pushed limb out of road with his tractor, National Grid left it in the middle of road after they fixed fallen wires. Deputy Supervisor Arnold would like Dave to bring issues up at next Highway Superintendents meeting and have a discussion with National Grid regarding displeasure.

Town Clerk stated that she has been reiterating with school and baseball/softball league that they can't have anyone except coaches parking beyond gate.
