REGULAR MEETING JANUARY 8, 2019 GALWAY TOWN HALL

#### Pledge to the Flag

A motion was made by Councilman Arnold, seconded by Councilwoman Grant to approve the minutes of the December 11, 2018 Regular Meeting & the January 2, 2019 Organizational Meeting as submitted.

Communications – Town Clerk stated that Board Members received copies of the following correspondence: Highway Department Report for December with schedule for January; Dog Control Officer's Report for November & December along with Shelter Report for November & December; Historian's Annual Report for 2018 & Assessor's Report for January. Other correspondence received: Thank you letter from GGCSA for Town's continued financial support of pantry. Clerk questioned when check goes out to pantry. Supervisor was not sure stated that pantry needed to send request. Notification was received from the Unified Court System that Hon. David DeVall had completed the Continuing Judicial Education Program; Need resolution for Supervisor to be a voting delegate at Association of Towns Meeting; Need resolution for Ainsley's Angels 5K road race; Galway Volunteer Fire Company Financial Report covering 12/6/17-12/4/18; Resolution is needed on proposed building permit renewal fee schedule; Resolution is also needed for the implementation of an Anti-Harassment Policy.

Dave Meager, Amsure Insurance Presentation – Dave Meager went over coverage with Town Board. Dave suggested that Highway Superintendent review values and get back to him with any corrections on equipment, making sure accurate depreciation values are noted correctly. There were three trucks that he felt may need to have adjustments made on value. He suggested Dave contact the dealers and find out what they believe the value is on that year truck with mileage. If the trucks are 10 years old or newer they are covered for replacement cost; over 10 years old accurate depreciation value comes into play. Town Clerk had asked Dave Meager for clarification on Tax Collector coverage since her warrant is currently over 2 million. Board & Dave went over options and felt no change was needed at this time with reference to Tax Collector. Dave gave a couple of possible changes to coverage with reference to deductibles. This year's renewal has decreased.

<u>RESOLUTION #: 2-2019</u> – Authorization to approve insurance package. Supervisor Smith stated that he would like to propose approval of insurance package in an amount not to exceed \$31,513.34. This not to exceed figure would then give Highway Superintendent the ability to reduce some of the equipment values if needed and not require Town Board to re-adjust resolution. On a motion of Councilman Arnold, seconded by Councilman Wilday the following resolution was ADOPTED by roll call vote:

RESOLUTION #: 6-2019 – Authorization for building permit renewal fee schedule. Supervisor stated this will be added to building permit packet. On a motion of Councilman Wilday, seconded by Councilman Arnold the following resolution was ADOPTED: AYES – 5 NAYS – 0

RESOLVED that the Galway Town Board authorize the following building permit renewal fee schedule:

At the conclusion of one year, a six-month extension will be granted for free. Contractor

& Insurance information must be updated along with Engineer's letter confirming compliance with current code requirements.

At conclusion of first free six-month extension, \$50 fee will be charged which will be good for an additional six months. Again, Contractor/Insurance/Engineer information will be updated.

At conclusion of both extensions if construction is still not completed a new application will be required and a fee equal to ½ of the original amount will be charged.

Marty from Saratoga County Prosperity Partnership will run meeting. Open to public, looking at trying to address idle businesses within Town. Supervisor Smith has met the person purchasing the Agway store and invited him. He has also talked with the new owners of the mini mall. Supervisor Smith has reached out to other business owners; planning/zoning chairs; school & village everyone is welcome. Marty will do a small presentation and open it up for discussion.
