SPECIAL MEETING JULY 25, 2018 GALWAY TOWN HALL

Supervisor Arnold called the Special Meeting to order at 7:00 p.m. The following Town Board Members were present:

Town Clerk stated Legal Notice was placed in the Daily Gazette on July 20, 2018 and posted at Town Hall; Library; Post Office; Bank & on Town Website advising the public of a Special Meeting to be held July 25, 2018 at 7:00 p.m. at Galway Town Hall to appoint Michael Smith to the Supervisor position for the remainder of 2018. This position will be voted on at the next General Election to fill the remainder of said term which will expire on 12/31/21. The Town Board would also be considering the request of Galway Emergency Medical Services to form a Special Ambulance District and to consider acceptance of a proposed plan, report and map of such District pursuant to Town Law Article 12-A.

RESOLUTION # 36-2018 — Appointment of Michael Smith to fill vacancy in Supervisor position for the remainder of 2018. On a motion of Supervisor Arnold, seconded by Councilman Wilday the following resolution was ADOPTED BY ROLL CALL VOTE:

RESOLVED that the Galway Town Board Appoint Michael Smith to the Supervisor position for the remainder of 2018. This position will be voted on at the next General Election to fill the remainder of said term which will expire on 12/31/21.

Supervisor Arnold accepted the resignation letter from Michael Smith from his position as Town of Galway Councilman effective 7/25/18.

RESOLUTION # 37-2018 – Schedule public hearing for proposed creation of Ambulance District. GEMS President, Beth Ruman stated that Board Members were given packets containing all required documentation for scheduling of public hearing. Beth went over the options available for Town Board with reference to this proposal. On a motion of Councilwoman Grant, seconded by Councilman Wilday the following resolution was ADOPTED BY ROLL CALL VOTE:

RESOLVED that the Galway Town Board approve the following resolution:

WHEREAS the Galway Ambulance Corps, Inc. d/b/a Galway Emergency Medical Services has approached the Town Board of the Town of Galway and proposed the creation of a Special Ambulance District under the provisions of Article 12-A of the Town Law; and

WHEREAS a map, plan and report, as required by Town Law Article 12-A, with regard to such District has been filed in the office of the Clerk of the Town of Galway, and

WHEREAS the Town Board desires to hold a public hearing pursuant to the requirements of Article 12-A so as to consider whether the map, plan and report together with such other information which may be received by the Town Board at such public hearing adequately support the creation of such district;

BE IT NOW RESOLVED and ORDERED that:

- A) The boundaries of the proposed district are hereby described as being co-terminus with the boundaries of the Town of Galway; and
- B) The maximum amount proposed to be expended annually for ambulance and emergency services is the sum of \$136,000.00;
- C) There shall be no improvements nor hookup fees proposed for this district;
- D) There is no financing proposed due to the fact that no improvements are proposed;
- E) The cost of the district on an annual basis to the typical one family residence which is valued at \$300,000.00 (assessed at \$159,000.00) and assuming that the maximum amount allowed to be expended annually is in fact expended is the sum of \$88.91;
- F) That a map, plan and report describing the proposed district has been filed in the Office of the Town Clerk of the Town of Galway and is available for public inspection at all times when the Town Clerk's office is open for business; and

PLEASE TAKE FURTHER NOTICE that a public hearing to hear all persons interested in the matter shall be held on the 14th day of August, 2018 at 6 o'clock in the evening of that day at the Galway Town Hall, 5910 Sacandaga Road, Galway, New York.
