MINUTES OF ZBA MEETING

Meeting Date: June 2, 2015

Meeting called to order at 7:30 pm by Acting Chair, Teresa Brett. Clerk called the roll:

PROCEDURE AND PURPOSE OF THE ZBA - Acting Chair explained the procedure and purpose of the Zoning Board of Appeals.

REVIEW AND APPROVAL OF THE MINUTES OF THE PREVIOUS MEETING

Members had previously reviewed the minutes of the May 2015 meeting. Motion by H.

Kopper to approve the minutes as presented. Second by C. McCormack. Voice vote: all ayes. Motion carried.

PUBLIC HEARING - opened at 7:32 pm

Clerk reads legal notice.

Application #ZBA15-005 – Application of Top Notch Tavern for area variance(s) to build a roof to cover the existing patio that runs along County Road 45 on property located at 712 County Highway 132 in the Consolidated Agricultural District #2 in the Town of Galway, tax parcel no.: 210.1.48. Mr. Palmateer explains what he is looking to do at his property. Explains that the area where the patio is located is in the Town of Galway. The fifty (50) foot requirement is not met. In looking at the plan Teresa notices that there is a drip edge. It is a foot. Herb asks where the measurement was taken from. Mr. Palmateer measured it from the center line of the road (which is 28 feet). It is seventeen (17) feet to the edge of the road plus a one (1) foot drip edge that will require a thirty four (34) foot variance.

Motion by C. McCormack to close the public hearing on applications ZBA15-005. **Second by H. Kopper.** Voice vote: All ayes. <u>Motion carried</u>.

PUBLIC MEETING
