MINUTES OF PLANNING BOARD MEETING

Date/Time of Meeting: June 25, 2019, 7:30 p.m.

MEETING CALLED TO ORDER at 7:30 p.m. by Chair, Ruthann Daino.

MEMBERS PRESENT: MaryLynn Kopper, Win McIntyre and Rebecca Mitchell

MEMBERS ABSENT: Mikel Shakarjian

ALSO PRESENT: Donna Noble, Clerk, James P. Trainor, Esq., and approximately eight (8) people in the audience.

REVIEW AND APPROVAL OF MINUTES: All board members previously reviewed the minutes of the May 28, 2019. **Motion by MaryLynn** to approve the minutes. **Second by Rebecca**. Voice vote: all ayes. <u>Motion carried</u>.

CLERK'S REPORT: None.

CHAIR'S REPORT: Correspondence from Saratoga County Planning Board - will discuss during the review of each application.

PUBLIC HEARING: Application #PB19-001 - Application of Erik and Kara Larson for a Minor/Major Subdivision of property located at 2759 State Route 29 (tax parcel no.: 161.-1-8) in the A/R District of the Town of Galway and the Rural Hamlet of Galway. Ruthann explains why we are having a second hearing on this application. As this property is located on a state road, (NYS Route 29) we did not send the application to the Saratoga County Planning Board for review before making a decision. They had their meeting on June 20. Their decision was that there is "no significant county wide or inter community impact" Ruthann reads their comments from the letter date June 21, 2019 (letter in the file). There are no comments or concerns from the board or the audience.

Application #PB19-003 - Application of Michael J. Germain Jr. for a Minor/Major Subdivision of property located at 6297 Barkersville Road (tax parcel no.: 173.-1-19) in the A/R District of the Town of Galway. There are no comments or concerns from the board or the audience.

Motion by Rebecca to close the public hearing. **Second by MaryLynn** Voice vote: all ayes. <u>Motion carried</u>.

PUBLIC MEETING: Application #PB19-001 - Application of Erik and Kara Larson for a Minor/Major Subdivision of property located at 2759 State Route 29 (tax parcel no.: 161.-1-8) in the A/R District of the Town of Galway and the Rural Hamlet of Galway. Ruthann has discussed, at length, with Mr. Larson the access to the rear property. There is less than 60 feet and 60 feet is needed for a future road if further development of site is proposed. You are only required to have 40 feet for a flag lot as long as you have 5 acres. There is no need to have 60 feet for a road as it would not be practical for this property. There is not much developable land to the rear.

Motion by Rebecca to approve the 2-lot minor subdivision. Second by MaryLynn. Voice vote: all ayes. Motion carried.

Application #PB-003 - Application of Michael J. Germain Jr. for a Minor/Major Subdivision of property located at 6297 Barkersville Road (tax parcel no.: 173.-1-19) in the A/R District of the Town of Galway. Application was sent to the Saratoga County Planning Board for review as the property is on a county highway. Their decision is to approve the subdivision. County Highway Department will approve a driveway when the time comes that the property will be developed per letter from Jim Clark. The comments regarding future development of lot 2 - a note will be added to the map "for future development of lot 2, reference Saratoga County Planning Board letter of June 21, 2019". This letter will be kept in the file.

Motion by MaryLynn to approve the 2-lot minor subdivision. **Second by Win**. Voice vote: all ayes. <u>Motion carried</u>.

PRIVILEGE OF THE FLOOR: Chris Kelley and David Schweizer are seeking guidance as they are looking for a place to put Mr. Kelley's bees. Mr. Dzierga owns the property that Mr. Kelley wants to purchase, creating a minor subdivision. It is not clear what zoning the subject property is in and there is concern ab out whether any of the property is in the Lake District as subdivisions are not allowed on private roads except in the Lake District, and property access if from a private road. It is determined to be partly in Lake district and partly in the A/R district. There are wetlands on the property. The issue could be that the subdivision may create a flag lot. The board checks maps and the code book. It is suggested that they fill out an application for a minor/major subdivision and/or

an interpretation of the zoning code. Mr. Schweizer is going to call Mark Kindinger.

OTHER BUSINESS: Galway Co-Op will be submitting a new application regarding some changes at the property on Fish House Road.

Motion by Rebecca to adjourn. **Second by MaryLynn**. Voice vote: All ayes. Motion carried. Meeting adjourned at 8:36 p.m.
