REGULAR MEETING MARCH 8, 2011 GALWAY TOWN HALL

Supervisor Hargrave called the meeting to order at 7:30 p.m. The following Town Board Members were present:

Insurance Presentation – Dave Meager of Adirondack Trust Insurance – Dave presented the insurance packet along with a summary of Insurance. Premium reflects an increase of \$621.39, just over 2%; there is a 4% increase in Building, Contents & Inland Marine values on items 10 years old & newer. Councilman Tillson went over some issues of concern regarding the way Selective Insurance is currently handling a claim. Dave will investigate concern and get back to Town with his findings.
