PUBLIC MEETING (Initial review/SEQR Review/Classification)

Application #13/001 – Application of Judy A. Kenyon and Joanne Gomula (property owner) for a subdivision of an approximate 5 acre lot from an approximate 100 acre parcel located at 4604 Jersey Hill Road 9Tax I.D. No. 211.-1-26 in the A/R district of the Town of Galway.

Mrs. Kenyon was present and addressed the board submitting a completed SEQR form on behalf of Mrs. Gomula who could not be present. Mrs. Kenyon stated that her attorney had advised her to ask for a one month postponement while the deeded easement for the driveway is being prepared.

Chair Ruthann Daino explained that Mrs. Gomula would either have to be present at the next meeting or sign permission on the application for Mrs. Kenyon to represent the project. In addition, she explained that any approvals for the subdivision would be delayed an additional month. Addressing Mr. Tillson, she inquired about how the removal of the existing trailer on the property would be handled — would want a guarantee in place for that removal prior to any approval.

Mr. Mike Tillson explained the removal of the existing trailer would be part of the building permit for the new Manufactured Home – only one home would be allowed on the property.
