<u>Communications</u> – Town Clerk stated that Legal Notice was placed in Daily Gazette on March 12, 2020 advising Town residents of a 4-ton weight limit on Town of Galway Roads; Legal Notice was placed in Daily Gazette on March 18, 2020 advising that all Town Board, Planning Board & Zoning Board Meeting had been cancelled until at least March 31, 2020 due to coronavirus emergency. FEMA Flood Risk Project Webinar was held on May 6th Clerk advised that information was given to Town Supervisor, Code Enforcement & Highway; neither Trevor or Town Supervisor attended webinar; Yearly insurance certificate was received from Crown Castle International regarding cell towers on Route 29, information was forwarded to Building Department and Planning Secretary for their files; Amsure Insurance Governmental Disclosure Statement; Budget Amendment; Letter from Chris Myers with concern regarding school flashing lights still running, Supervisor Smith sent letter regarding his concerns; NYS Department of Transportation regarding speed limit reduction request for Cruthers Road advising that this is a unpaved highway physical characteristics control operating speeds in themselves (copy of letter was forwarded to resident Monica Vanderhoof that requested reduction); email correspondence from Attorney Trainor on how to open Planning & Zoning Meetings & Highway Department Maintenance Report for April with schedule for May.

Board felt that Family Fun Day at this point should be cancelled. Town Clerk asked status of ball field scheduling of usage. Supervisor Michael Smith stated closed as of this time. Planning Board has been told by Town Supervisor to go ahead and schedule their meetings. Supervisor suggested holding those meetings at Town Pavilion. Town Clerk stated that the back-parking lot here at Town Hall would probably work better for power and then the clerk would not have to place yet another legal notice with location change. Code Enforcement Officer, Trevor Gilday suggested virtual meetings. Supervisor Michael Smith was not comfortable with the virtual approach. A Fiber Optic Company has reached out to Supervisor and he will be looking into it further to possibly replace Spectrum. This is just available for School Districts; Municipalities and he believes businesses. Supervisor will keep Board advised on how this pans out. Trevor advised that they processed 17 building permits. Town Clerk questioned if these people were allowed to begin work on projects once they obtained these building permits. Trevor stated that residential construction is still closed except for emergency type repair. Clerk questioned how one-year permit would work for renewal purposes. Trevor stated he would be working with people, bringing into consideration shut down period by State. Supervisor Michael Smith felt the County was very close to meeting all seven of the

criteria boxes for opening. He feels the Town Hall will be open to public between 5/26 & 6/2/20.

RESOLUTION #: 27-2020 – Agreement for Expenditure of Highway Money. On a motion of Councilwoman JoAnne Grant, seconded by Councilman Fred Arnold the following resolution was ADOPTED: AYES – 4 NAYS – 0

RESOLVED that the Galway Town Board accept the agreement for the expenditure of highway money in the amount of \$366,500.00 for 57.76 miles of town highways, including sluices, culverts and bridges having a span of less than five feet and boardwalks or the renewals thereof.
