Application - #PB17-001: Application of Joyce Gaudreau and Rebecca and James Penn, for a lot line adjustment to merge two lots located at 1015 and 1016 Camp Road, (tax parcel nos.: 185.17-1-36 and 185.17-1-38) in the Lake District in the Town of Galway.
