PUBLIC HEARING/WORKSHOP JUNE 8, 2021 GALWAY TOWN HALL

Deputy Supervisor Fred Arnold called the public hearing to order at 6:20 p.m. The following Town Board Members were present:

OTHERS PRESENT: J. Trainor, Attorney & M. DeFoe, Town Clerk.

Town Clerk read legal notice placed in the Daily Gazette on 5/20/21 advising the public that the Town Board would conduct a workshop to receive public comments regarding the NYS Marijuana Regulation & Taxation Act ("MRTA") and its impact on the Town of Galway, including but not limited to whether retail dispensaries should be allowed in town in exchange for receiving up to 3% sales tax. Residents may participate in person at workshop or in writing by 4:00 p.m. on June 8, 2021. Town Clerk stated additionally posted at bank, post office, town website & the Facebook page Supervisor Smith set up for Town. Town Clerk stated she received no written or oral comments regarding MRTA.

Deputy Supervisor Fred Arnold introduced James Trainor, the Planning/Zoning Attorney to go over the information he has on MRTA. Jim advised that he gave Board Members three packets outlining options and information available at this time. Jim stated that Towns could opt out of letting Cannabis Retail Dispensaries and on-site consumption licenses to be issued in their Towns. If Town decides to opt out, they must pass a Local Law by 12/31/21. If Town opts out, the public still has the option of a Permissive Referendum. If Town chooses not to opt out, they can zone laws which would restrict time, place & manner which sales and on-site cannabis use can take place. Jim stated that Town could opt out and after the state fine tunes regulations they could opt back in. Councilmember Ryan Flinton stated he felt opting out now would allow the Town to do a much-needed updating of our Town Code and then incorporate MRTA usage later. Attorney Trainor suggested opting out now, see how the state works out kinks in regulations. Town can opt in later when regulation issues are cleaned up on state level. On a motion of Councilmember JoAnne Grant, seconded by Councilmember Ryan Flinton the meeting was adjourned at 6:44 p.m.

REGULAR MEETING JUNE 8, 2021 GALWAY TOWN HALL

Communications – Town Clerk stated that last month the Town Board discussed having a bulk waste drop off. Deputy Supervisor Fred Arnold stated that he would like Highway Superintendent to come up with dates for this. April Highway Report with Schedule for May; May Highway Report with Schedule for June; Information on CHIPS, PAVE NY & EWR FUNDS; Budget Amendments for Highway & Youth Commission; Planning Board Member is needed, Dave Schweizer doesn't want to be reappointed; Assessor Report for June; Signed contract between Saratoga County & Town for the Galway Recreation Program & Youth Referral Services; Notification of a Utility Moratorium covering recent legislation regarding protections previously granted to utility customers last year and impact on towns, to be held 6/10 at 11a.m.; A couple correspondence from Charter Communication regarding upcoming changes; Thank you from Galway PTSA for After Prom Donation; Supervisor Michael Smith signed a contract with Galway Trailmasters to allow them usage of parking lot area and to the gate at the back of the property at Dockstader Fields; Notification from Milton Planning Board of Public Hearing on May 19<sup>th</sup> at 7:10 p.m. regarding the Austro Solar Farm special use permit & site plan review; Social Security Star Newsletter; Resolution from Attorney Horigan on clean-up of Vassel's property & Speed limit reduction request for Crooked Street between Hart A Road & Hermance Road.

#### COMMITTEE/DEPARTMENT HEADS/LIAISON REPORTS: Youth

Commission – Donna Sowle, Chair advised that spring soccer is going strong, they have over 90 children participating which runs thru June 19th; Family Fun Day will be held at Dockstader Fields this year on June 19th from 1-4 p.m.; Donation of \$50 from Village & \$300 from Town of Providence for Family Fun Day; Summer Program will run July 12th thru August 5th, Monday thru Thursday's from 9:30-noon at Dockstader Fields. Highway - Dave Costanzo stated for May the Highway Department started the reconstruction of Point Road & Spring Road; started spring/summer recreation field maintenance; started mowing of ROW's & Town Hall complex; paved with Ballston, Charlton, Greenfield & Milton; Under Federal Surplus Highway Department purchased a single axle plow truck & a vacuum truck & hauled gravel to shop for road reconstruction. The schedule for June will be to pave Point Road, Spring Road & Hoesville Road; continue spring/summer maintenance on recreational fields; continue mowing ROW's & Town Hall complex; Install homerun fences at ball fields & pave with Ballston, Charlton, Greenfield & Providence. Dave stated that he received information regarding CHIPS, PAVE NY & EWR additional funding in the amount of \$186,251.51. Budget amendment needed for additional insurance reimbursement. Bulk waste drop off can be set-up for September 21st thru 24th and September 28th thru October 1st from 6-4 p.m.

Councilmember J.D. Arnold made a motion, seconded by Councilmember Ryan Flinton to approve the May 2021 General Abstract of Vouchers (A) for a total of \$20,516.86.

Town Clerk stated that Supervisor Smith advised her today to authorize Highway Superintendent to spend funding but not to increase account. Increase in fund will occur when check is actually received. On a motion of Councilmember J.D. Arnold, seconded by Councilmember Ryan Flinton the following resolution was ADOPTED: AYES – 4 NAYS – 0

RESOLVED that the Galway Town Board authorize the Highway Superintendent to spend up to \$186,251.51 in anticipation of CHIPS, PAVE NY & EWR funding, his account will be reimbursed when funding is received from State.
