PUBLIC HEARING:

Application #PB22-003 - Application of Kathryn Kellman, for a Home occupation permit on property located at 6230 Green Corner Road (tax parcel no.: 172.-2-39) in the Town of Galway. Mrs. Kellman is in attendance. Jared Lagrand of 6224 Greens Corner, shares a driveway with Mrs. Kellman. Ruthann discusses the email she received with questions and concerns the impact that the business will have on the driveway. Jared States there is no easement granting access to either party, Mr. Lagrand is concerned with the public Facebook posts about camps being held at the property. Questions about liabilities of camps and extensive traffic with multiple cars, Concerns with privacy issues and high traffic that the home owners do not think they should have to encounter. Kathryn states she originally hoped to put in a parking lot, but after speaking with Code enforcement there was not enough room. Kathryn works with 1 individual at a time, At this time Between Jan and July saw a total of 176 People in session which works out to be an Average of 6 People a week in person, with the possibility of 2 people overlapping at a time, States there is space at her house for parking. Kathryn's Mother built both properties and the driveway accessed both houses at one time. Kathryn states she has extensive signage and directions for parking for clients.
