Town of Galway, New York PROCLAMATION Honoring Mark L. Wilde

WHEREAS, the freedom, security and prosperity that the American people have enjoyed throughout the history of our nation has preserved due to the heroism and sacrifice of the men and women who have served in our armed forces, and,

WHEREAS, the Galway Town Board wishes to honor and memorialize the lives and courageous deeds of the members of the armed forces who have served with distinction in the defense of our nation, and,

WHEREAS, Mark L. Wilde served in the United States Army from April, 1970 through November, 1971 seeing combat action in Vietnam during his time in the Army. He was part of the 101st Aviation Battalion of the 101st Airborne Division and assigned to and

trained as Army Aircraft Maintenance Technician. Mark rose to the rank of SP4 prior to his discharge from the Army, and,

WHEREAS, Mark received for his service to his country the National Defense Service Medal, the Vietnam Service Medal and he was award a Bronze Star Medal for meritorious achievement in ground operations against hostile forces, and,

WHEREAS, Mark upon his return to Galway worked as a carpenter for several companies and later operated his own contracting and carpentry business for 25 years. Mark's skill and craftsmanship was recognized by building contractors throughout the Galway area, and,

WHEREAS, Mark was a member of the American Legion Post 1461 and served as Post Commander as well as Commander of the Guards in the annual Galway Memorial Day Parade, and,*

WHEREAS, it is fitting that the heroic service and sacrifice of Mark L. Wilde, for his nation and community, be recognized and remembered and his memory be honored, NOW, THEREFORE, BE IT,

PROCLAIMED, that the 12th of December, 2017 is hereby dedicated to the memory of Mark L. Wilde in grateful recognition by the Galway Town Board on behalf of the citizens of the Town for the service and sacrifice made by him in the defense of his country. Supervisor Paul E. Lent
