Communications – Town Clerk read Legal Notice placed in The Daily Gazette on April 7<sup>th</sup>, 8<sup>th</sup> & 9<sup>th</sup> advising that the Town of Galway would accept sealed bids for the purchase of Asphalt Concrete. Board Members received copies of the following correspondence: Historian's Report for April; NYS Retirement ENews for April; Assessor Report for May; Highway Department Report for April with Schedule for May; Building Department Report covering 4/12-5/10/16; Budget Amendment; Resolution needed on Standard Work Day & Bid Recap from the County on Transit Mix Concrete.

COMMITTEE/LIAISON REPORTS: Farmers Market - Councilman Arnold stated that they are moving along will have another meeting next week to determine if they are going to end up having Farmers Market. Highway - Superintendent Costanzo stated for April they plowed and sanded; cut brush & trees; cleaned up trees & barn from storm; assisted Greenfield with paving; assisted Charlton hauling gravel; removed 4-ton weight limit signs; mowed ball fields and Town Hall; hauled gravel to shop and swept sand. Highway Department re-graveled; graded; rolled and topped with calcium all gravel roads. Code Enforcement - Nothing in addition to written report. Youth - Donna Sowle advised that Soccer is going well; Family Fun Day is June 18th 1-4 p.m. invited Officials to attend; Summer Rec is gearing up & working on getting a swimming program. Councilman Smith stated that parking issues on ball fields have been resolved. Donna questioned status of Girl Scout Silver Project with reference to garbage pickup at ball field. Town Hall has had no further contact with Scouts since their presentation.

# **MOTION CARRIED**

Supervisor Lent went into discussion with Town Board & Highway Superintendent with reference to setting date for bulk waste drop off. It was determined that the dates for collection would be June 8<sup>th</sup> thru 12<sup>th</sup> at Highway Department, times to be determined. Highway Superintendent will have list prepared on what is allowed for drop off and what is not. Roll off will be used from County. Newsletter articles are due by May 18<sup>th</sup>. Town will have information regarding drop off in newsletter; County website; Town website; Supervisor will also do news release. Supervisor Lent stated that budget impact is unknown at this time; this is the first time Town will be doing something of this magnatude. Resolution was done in March allowing up to \$5,000, Supervisor Lent stated we would most likely need to alter that next month after actual figures come in. Overview of this drop off: will be held June 8<sup>th</sup>-12<sup>th</sup>; hours of operation to be determined, approximately 6 a.m.-6:30 p.m. during that week and 8 a.m. – 4 p.m. on weekend; roll offs will be delivered from county; Highway Superintendent will make list of non-permitted items and bill will be addressed upon completion with county waste.

<u>Privilege of the Floor</u> – **Donna Sowle** requested that the Highway Department remove an old bench at ball field before someone gets hurt on it. Dave stated that they would take care of removing it. **Councilman Smith** stated that they were working on addressing an issue on Lake Road where the school bus is being passed. Supervisor Lent talked with Sheriff's Department regarding this. **Victoria Kramer** of 1409 Route 29 questioned when Farmers Market was scheduled to open. Councilman Arnold stated that anticipating later part of June or beginning of July will hopefully have information on Farmer's Market in newsletter.

Councilman Arnold made a motion, seconded by Councilman Smith to adjourn the meeting at 7:39 p.m.
