Supervisor Lent called the meeting to order at 7:30 p.m. The following Town Board Members were present: Same as Public Hearing

A motion was made by Councilman Arnold, seconded by Councilman Smith to approve the minutes of the September 13, 2016 Regular Meeting as submitted.

Communications – Town Clerk stated that Board Members received copies of the following correspondence: Building Department Report covering 9/1 – 10/11/16; Historian's Report for October along with a copy of Volume 1 of the Papers of Joseph Henry for each Board Member & Clerk; NYS & Local Retirement System Employer E-News for September; Assessor Report for October & 2017 Tentative Budget. Correspondence was received from NYS Department of Agriculture & Markets regarding Dog Control Officer Inspection Report completed 9/19/16 indicating a Satisfactory rating & an executed copy of the Youth Service Project Agreement.

Supervisor Lent stated that Matt Schuette, Representative from Jaeger & Flynn was here tonight regarding Town's Health Insurance Package Options. Matt advised that the current plan with CDPHP would be going up 14.24%. The BSNENY Plan has a higher deductible that the previous CDPHP Plan, but the Town will be able to set up a reimbursement plan like they did last year due to their savings. Matt explained that the network participation is basically local 13 counties participation. This plan doesn't allow national network participation, meaning (example: Boston or New York City would not be covered under network). Town would also offer a MVP Plan for employees as a buy up with difference in cost for plan to be employee's responsibility. This Plan would allow the employee the national network participation. Supervisor Lent gave the example for the single plan that if they chose to buy up it would cost them an additional \$7.41 per month from their current payment. If that same individual employee chose the BSNENY Plan it would be a savings of \$9.40 per month. Matt explained that the \$600.00 deductible reimbursement plan would be done thru Jaeger & Flynn not Town. Matt stated that five employees participate in Plan; he has never seen every employee use their full deductable. Worst case scenario would be a \$4,800 pay out by Town if all five employees used their entire deductable. The administrative fee will be \$300 plus \$4 per employee per month. Supervisor Lent stated if you added all the deductable amount and fees associated with administrative handling by Jaeger & Flynn we will still be slightly under what the Town is currently paying for Health Insurance Coverage today.

Supervisor Lent went into discussion with Town Board on why it really wasn't a good idea for Town to be the ones working on the employee's deductable reimbursement. Discussed dental option, currently that would be 100% employee cost with a percentage of eligible employees require to participate in plan for it to be offered.

Youth Commission — Donna Sowle stated that youth soccer would be completed on Saturday, weather permitting. Basketball will begin the 2nd week of November and run into February. Councilman Smith stated gate was going to be installed at ball field to keep people from driving to back fields. Donna stated that would be the travel soccer, not recreational soccer that is driving to back fields. Donna commented on how good both signs looked at ball field. Donna stated thank you note was received from family regarding swim program.
