**2024 Town & County Tax Bills** will be mailed to reach you for January 2<sup>nd</sup>, 2024.

\*\*\*If you don't receive your tax bill by the 13<sup>th</sup>, please give our office a call (518) 882-6070 ext. 11.

\*\*\*If you no longer own property and you have received the tax bill, **PLEASE** return the bill to us with the new owner's name and address so we can forward the bill to them.

\*\*\*If you have recently purchased property and you have not received a tax bill, call our office and we will make sure a bill is forwarded to you.

\*\*\*If you received a tax bill and your mortgage is in escrow, chances are the bank didn't request the bill before the mailing date. Just forward it to your mortgage company.

Tax payments can be paid in person at the Galway Town Hall, 5910 Sacandaga Road on **Monday's in January ONLY** from 7 a.m. to 5:00 p.m.; Tuesday, Wednesday & Thursday from 7:00 a.m. to 5:00 p.m.

\*\*\*If paying in person checks are made payable to Town of Galway Tax Collector and cash payments require **exact change.** 

\*\*\*If mailing tax payment: Town of Galway Tax Collector, 5910 Sacandaga Road, Galway, NY 12074, PLEASE MAKE SURE YOUR TELEPHONE NUMBER IS ON CHECK.

\*\*\*Tax bills are due by January 31st post mark date with no penalty.

\*\*\*If paid from February 1<sup>st</sup> to 29<sup>th</sup>, there is a 1% penalty and must be post marked by February 29, 2024.

\*\*\*If paid from March 1<sup>st</sup> to 31<sup>st</sup>, there is a 2% penalty plus \$1.00 and must be post marked by March 31<sup>st</sup>.

No tax payments can be made beyond March 31st at Galway Town Hall.

AGAIN, PLEASE INDICATE ACCURATE TELEPHONE NUMBERS ON CHECKS WHEN MAKING PAYMENTS. We have found that many people are no longer using land line and just using cell phones. If we have an issue with your payment for any reason the first thing we try and do is contact you by telephone before returning the payment to you. This could be the difference in your payment being payed on time or a penalty amount needing to be added. So please double check and make sure that phone number is indicated on your payment, it will make things easier for you and me.

For the 2024 Tax Season the Town of Galway will continue to accept Credit Card payments. Property owners have the option to pay their tax bill by Credit Card/Debit Card/E-Checks. At the Town website: townofgalwayny.org under Tax Collector you can still pull up and view bill status along with additional option to pay bill online. \*\*\*All Credit Card/Debit Cards will be subject to a service fee of \$1.75 up to \$64, over 2.75%; E-Checks Access Fee \$0.01 to \$1,999.99-\$2.50; \$2,000 to \$3,999.99-\$5.00; \$4,000 to \$5,999.99-\$7.50; \$6,000-\$7,999.99-\$10.00; \$8,000-\$9,999.99-\$12.50; Over \$10,000 Increments of \$2.50 per \$2.000.\*\*\*
